From 2002 to 2006, he was Chairman of the Board. Since 2006, Kai has been an investor in the global telecommunications and Internet sector, with various Board positions. He is also co-initiator of a private equity fund.

What would you have liked to have known during your time at EBS but only learned later?

"I would have liked to have had a better understanding of the true nature of the mind much earlier. How many emotions and fears, and the resulting attitudes and projections, determine one's character and thus human life. Graduation 1999 | Business

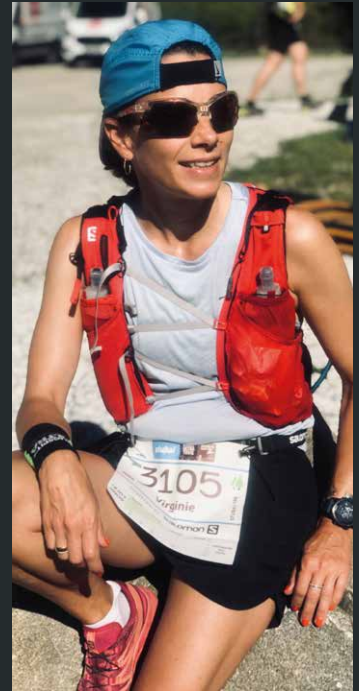
## Owner and managing partner of the agency 19:13

## Managing director of LMM Investment Controlling AG

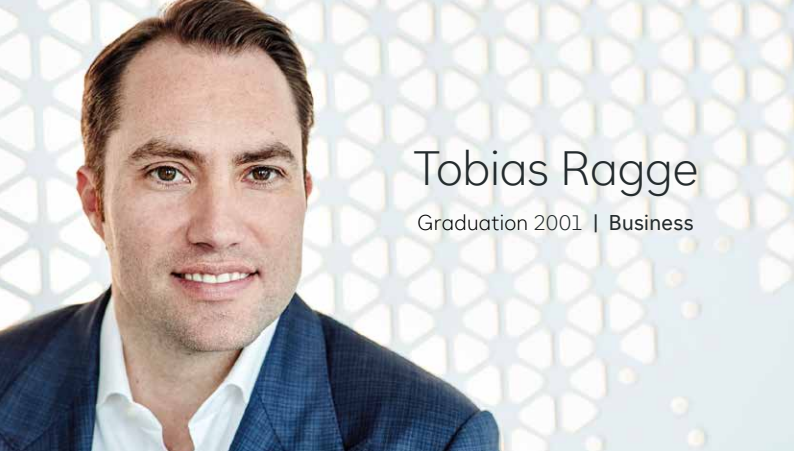

Starting this year, she has also been involved as an Advisor to the Bill & Gates Foundation's Nutrition Strategy Roundtable.

## Lilian Ebner-Stoll |

### Which people have inspired you and why?

"Professor Karin Kreutzer and Dr Andreas Blüthner. Ms Kreutzer holds the Chair for Social Business at EBS and has shown me new ways to use my studies to do good. She has taken on the role of mentor for me and opened many doors, for instance to UNICEF. And she invited Andreas Blüthner as guest speaker. At the time, he was Director of Food Fortification at BASF and is now Director of Nutrition at the Bill & Melinda Gates Foundation. He planted the idea of nutrition as a human right in my head, encouraged me to start my own business and gave me a great deal of support. Both have taught me to always think about 'impact at scale' and to build models that can reach not only just hundreds, but millions of people."

Shortly after, Saskia co-founded Yunus Social Business, together with Nobel Peace Prize winner Muhammad Yunus and EBS alumna Sophie Eisenmann, which she still leads today as CEO. She is also a Member of the Boards of Impact Bridge, MyCollective and EVPA, among others, and co-initiated the World Economic Forum's COVID Response Alliance for Social Entrepreneurs. In 2020, Saskia was awarded the Bold Woman Award by Veuve Clicquot for her efforts to improve capitalism.

## Saskia Bruysten |

### Which person has inspired you and in what way?

"That was most definitely Muhammad Yunus, the Nobel Peace Prize winner from Bangladesh. I first heard him speak at a lecture in London. At that time, he talked about his micro-credit bank which, with its economic approach, helped millions of women out of poverty. He also talked about a social business joint venture with Dan-one, which was selling fortified yoghurt to fight malnutrition in Bangladesh. This was a light-bulb moment for me to see how the power of business can be harnessed to address social problems. At that time, I was just asking myself after several years in management consulting that essential question about the reasons for doing this job. After many conversations with contacts from companies, NGOs and in politics, nothing had really grabbed me yet. When Prof. Yunus gave his speech, something clicked. That's exactly what I wanted to do! I was so enthralled by his story that I immediately gave him my business card and later met him to exchange ideas. In the end, we founded our organisation Yunus Social Business ten years ago, together with another ex-EBS student, Sophie Eisenmann. Now I'm very happy to say that every day we use the power of business to tackle social or environmental problems!"



## Co-founder of HydroNeo

During his studies at EBS (General Management and Business Law), Fabian also got involved as a student representative. Afterwards, he was a Management Consultant at Barkawi Management Consultants. Since 2016, Fabian has been Vice President of EBS Alumni e.V. In 2018, Fabian co-founded the start-up HydroNeo. ## Founder of Lieferando and COO of Just Eat Takeaway.com

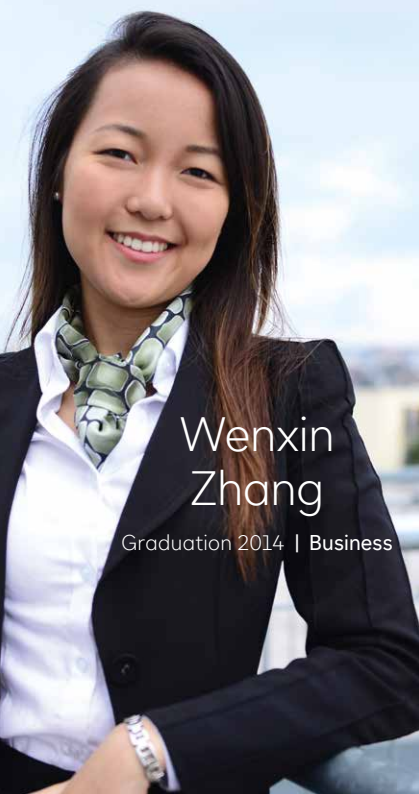

### What is your philosophy in life?

What will remain at the end of my life is not the job title I had at the age of 26, or the salary I was paid at 32, or the car I drove at 43 – what will remain and hopefully outlive me is the richness of the book I wrote. Writing the best story I could is the most important thing to me – and I use that as my guiding principle when making decisions.
